Criteria for Age Groups U17, U19 and U21 Eg: A player Trialling for U17 must be UNDER 17 as at 1st January 2012.

Final Trial – Sunday 1st April 2012

Check in from 9.30am

Performance Squad Selection and U19 / U21 Representative Trial process

For 2012 Netball North will be running a compulsory pre-season strength and conditioning programme, as part of the trial process, for all players who wish to be eligible for U19 & U21 Representative selection.

**To be eligible for selection in 2012, players must be a registered member of a Netball North Netball Centre.

Note: There is an investment of \$35.00 per person to attend, see registration form.

On the 18th there will be an introduction to the process, a who's who, skill and fitness test, plus each player will be given a summer programme to commence and work through.

U19/U21 Schedule:

2. 18th Dec - 29th January . Summer programme
3. **Sunday 22nd January – squad meeting 9-1pm - check in from 8.30am – Venues TBC.**
4. 23rd Jan . 26th February . General Training programme with possible scheduled practice games.
5. **Sunday 26th February – squad meeting 9-1pm - check in from 8.30am – Venues TBC**
6. 27th Feb . 31st March - General Training programme with possible scheduled practice games
7. **Wednesday 5th April – Final Trial - 6-9pm – registration from 5.30pm – Onewa Arena, NNH.**
 - i. Players will be advised whether a second Trial will be required or if the team is to be named on the Netball North Website on 9th of April.
8. April . July . Training continues with the Coach and Strength and Conditioning programme in preparation for Nationals.

The Venues for sessions on 22nd Jan & 26th Feb are to be confirmed and dependant on the number of trialists and the areas they are from.
